II. Welcome and Introductions

III. Approval of November Meeting Minutes

IV. AZPOINT Portal, Heather Bohnet, AZ Criminal Justice Commission

- a. Heather Bohnet presented a high-level overview of the AZPOINT system and provided a demo of the portal.
- b. Victims can fill out a petition online. The victim has 90 days to file with the court. After 90 days all data will be deleted from the system and the victim will need to complete another application.
- c. If the victim files with the court the OOP, if signed by the court, will go directly from the court to law enforcement for service.
- d. The order is automatically uploaded into NCIC.

- e. Emergency orders are now valid for 72 hours.
- f. Kennesha Jackson shared that the link to the AZPOINT portal will be on the new Request Waiver Form and will be available in September.

V. 2020/2021 Membership Year Vote

b. Fee Structure

i. The Executive Committee put forward a recommendation that the fee structure, voting rights and benefits remain the same for 2020/2021 membership year. Dan Levey motioned to accept the recommendation. Carolee Holbrook seconded the motion. Motion passed unanimously.

- b. ACESDV Katie Eres
 - i. Supporting sexual violence specific services administered through DES. Reviewing repeal of parental rights of rapists. ACESDV supports changing the language from 'conviction' to 'clear and convincing evidence' which will be in line with other states.
 - ii. SB1120 Safe and Healthy Students Act Support
 - iii. HB2277 Companion House bill to SB1120 Support
 - iv. SB1082 Oppose this bill

VII. State Agency Coordinating Team (SACT) – Funders Reports

- a. VRP Kennesha Jackson, Arizona Attorney General's Office
 - i. FY 2020/2021 Funding Update Agencies will receive their FY21 VRP second installment end of January/beginning of February. FY21 Performance reviews have been issued in GMAN and are due February 7, 2020. If your agency is in the VRP Program and anticipates vacancy savings for FY20, please submit a budget modification request form. We encourage agencies to spend all of the VRP monies.

- ii. Distinguished Service Awards (DSA) Currently soliciting nominations for 2020 DSA awards. Please share with your agency's employees and contacts. Nominations are due Friday, January 17, 2020. Awardees will be recognized during the National Crime Victims' Rights Week event during the week of April 19 – 25, 2020 in Phoenix.
- iii. Trainings There is a new advanced training this year that will focus on the appeal process. Please refer to the Victims' Rights Training schedule online for a list of dates for this winter and spring.
- iv. VRP is looking at funding for FY 21 but is anticipating a reduction in funding. Agencies will be receiving a letter soon.

b. ACJC — Heather Bohnet

- i. Victim Assistance Grant Funding
 - 1. ACJC has seen significant declines in funding. The revenue stream changed formulas in January of 2019 and ACJC has not received any funding under the new formula. \$1.25 million decrease in funding. Funding will be voted on at the end of January. The Victim Assistance Grant will either be eliminated or be significantly reduced to \$200,000 and will most likely focus on Tier One projects only. ACJC will conduct a grant orientation webinar February 3 from 1:00 2:30 assuming funding is available. Grant will open February 4; closes March 20.

ii. Victim Compensation

1. ACJC is developing an online application for compensation and has been working with some operational units for testing; no date on when it may be complete.

iii. Other ACJC news

- ACJC received a federal grant for a statewide victim notification system to start with jail and ADC release notification; ACJC will reach out to partners/stakeholders for a workgroup in the near future
- The new Orders of Protection Portal went live January 1, 2020 and individuals will be able to file a petition online; statewide training is available.

c. DPS - Sheri Doll

 i. SACT grant writing training registration has closed. This grant writing class is not VOCA specific and will be presented by OVC TTAC. Phoenix locations are currently full but there is some space in both Flagstaff and Tucson. The training will be held in Phoenix – BLM Office near Metro

Center; Flagstaff – Flagstaff Law Enforcement Administrative Facility; and Tucson – Southern Arizona Children's Advocacy Center. A webinar will be held prior to the training and will be recorded.

- ii. VOCA DPS will announce the VOCA funding process at the end of February. This will be for a 3-year grant. They are currently unsure of funding availability as the 2020 award has not been announced. Funding is trending downward and the VOCA fund balance is significantly lower. DPS hopes to maintain current funding levels for year one but agencies should expect reductions in years two and three of the grant.
 - 1. There will be a pre-application conference on March 11 and 12 at the Glendale Regional Public Safety Training Center. Participants should plan to attend one day.
- iii. Any questions regarding the grant need to be presented to your grant coordinator by mid-February. DPS will not be able to answer any questions after the grant is announced. Any questions after the announcement should be directed to Kate Lyon but she will be limited on what she can answer. Registration information will be part of the RFGA.
- iv. Participants can also look at the Q & A and PowerPoint from the last grant period. These are on SAGE.

 - i. ARS 41-1727 Victim Rights Enforcement Fund. Currently \$2.00 and administered by DPS. Wants to allow technical assistance and training to be covered by the fund. Wants to update ARS 12-116.09 to increase the fee to \$3.00.
 - ii. 13-805 Clarifying language for the court to retain jurisdiction over restitution.
 - iii. DOJ GAO report on restitution nationally on how agencies are doing in collecting restitution. Asking that ACJC keep track of collecting restitution statewide. Currently clerk of court tracks this information for each county.
 - iv. 13-4434 Victim Privacy Current statute states that identifying information on victims shall be redacted before giving to defendant.
