Dan Levey – They have met with MCAO to discuss modifications to ARS §13-4434 that requires records to be redacted of any victim contact information before disclosure to the defense team or the defendant. Due to the volume of materials they are discussing possible changes to include notification to a victim and/or a right to be heard before a judge if their information would be disclosed to the defense team. These discussions are in early stages and Dan appreciates MCAO involving stakeholders and victim groups in giving feedback on potential changes.

VII. State Agency Coordinating Team (SACT) – Funders Reports

- a. VRP – Kennesha Jackson, Arizona Attorney General's Office:
 - i. FY 2021/22 Funding Update – FY22 VRP second installments will be disbursed in January 2022. They are currently also preparing for FY23 grant period. FY23 Performance Reviews will be issued Mid December. If your agency is in the VRP Program and your agency anticipates vacancy savings for FY22, submit a budget modification request form. They encourage agencies to spend their full award amount.
 - ii. Distinguished Service Awards (DSA) – Currently soliciting nominations for 2022 DSA awards. Please share with your agency's employees and contacts. Nominations are due Friday, January 7, 2022. Awardees will be recognized during the National Crime Victims' Rights Week event during the week of April 24th-30th, 2022 in Phoenix. Nominations can be completed online at <https://www.azag.gov/dsa-nomination-form>. Keep in mind; you can nominate those you've nominated in the past who were not selected.
 - iii. Victims' Rights Education – Outreach and education presentations will continue to be conducted via webinar. New Advanced training curriculum and updated Basic are available for registration. For more information on the schedule, to register, or to request a private presentation for your office please contact OVSTraining@azag.gov or visit <https://www.azag.gov/criminal/victim-services/training>. This year, victims' compensation training will not be included in the Basic and will only be available through the ACJC website. Instead, they have expanded the post-conviction section to help ensure a better understanding of that process. Advanced curriculum this year will, in addition to a legislative and case law update, cover death penalty cases and how those cases impact victims.
