b. Criteria

- i. Complainant has to be a victim, lawful rep, or Victims' Rights council
- ii. Complaint has to be made within one year of alleged violation
- iii. Has to be regrading a specific Victims' Right in a criminal case
- c. Initial contact is made
 - i. Victim will be required to provide relevant info and documents

- e. If no violation is found, Kirstin Flores sends a letter to the agency and to the complainant
- f. If a violation is found:
 - i. Meeting is scheduled with Kirstin Flores, council, and sometimes AGO Criminal Division Chief
 - ii. A letter of findings is sent to the victim
 - iii. A letter of findings is sent to the head of the agency with the violation including steps necessary to avoid future violations

VI. Update regarding Lifetime Injunctions – Amy Bocks (<u>amy.bocks@azag.gov</u>)

- a. If a defendant and Application to Set Aside Judgement or Petition to Seal Criminal Case Records, the Lifetime Injunction is not affected
- b. The statute does not give defendants the chance to object to Lifetime Injunctions, but per Jamie Balson the courts are allowing it
 - i. Courts have been waiting 21 days for defendants to object or be heard and so it is taking 30-45 days

VII. Legislative Priorities

- a. Ryan Clark, AGO:
 - i. HB 2184 Severe Threat order of protection (STOP), Rep Jennifer L. Longdon (NO MOVEMENT) (Laurie Kalivas asked for an update)
 - 1. Establishes the option for petitioners to file a STOP under specific circumstances.
 - 2. No movement
 - **ii.** HB2482 Appropriations; crime victim notification fund, Rep Payne (NO MOVEMENT)



- 1. The sum of \$3,750,000 is appropriated from the state general fund in fiscal year 2023-2024 to the law enforcement crime victim notification fund established by section 41-180, Arizona Revised Statutes.
- 2. The sum of \$250,000 is appropriated from the state general fund in fiscal year 2023-2024 to the state treasurer to evaluate, certify and pay for any costs associated with the law enforcement crime victim notification fund established by section 41-180, Arizona Revised Statutes.
- 3. Transmitted to Senate 3/07/23
- iii. SB1197 Juvenile offenders; monetary sanctions; repeal, Rep Gowan (NO MOVEMENT)
 - 1. Proposes *repealing* ARS 8-418 which currently requires parents of juveniles adjudicated delinquent in cases with a victim to pay \$25 into the VRP.
 - 2. Transmitted to House 3/09/23
- iv. SB1244 Appropriations; crime victim notification fund, Rep Kavanagh (NO MOVEMENT)
 - 1. Makes clarifying amendments to ARS 41-180.
 - 2. Minority/Majority Caucus 3/07/23
- v. SB1304*** Home arrest; electronic monitoring, rep Kaiser (NO MOVEMENT)
 - Adds 41-1604.21 (E)(F) and allows for home arrest for persons convicted under certain circumstances. Bill includes eligibility; victim notification; conditions; fees; timelines, etc
 - 2. Victims notice and rights included (but not written in victims' rights statutes) and consist of: notification of the inmate's application, victims' right to request a hearing and be present at the hearing and to submit a written report.
 - 3. Does not indicate if victim must be opted in for post-conviction notice.
 - 4. If BOEC does not receive a hearing request from the victim, they shall approve the release to home arrest
 - 5. Includes conditions of home arrest
 - 6. Does not mention payment of restitution but does mention payments of various fees
 - 7. Majority Caucus 2/21/23
- i. SB1475*** Death penalty; repeal, Rep Mendez (NO MOVEMENT)
 - 1. 13-751 Sentence life or natural life imprisonment; victims' rights
 - a. If the court imposes a natural life sentence, the court shall order that the defendant not be released on any basis for the remainder of the defendant's natural life.
 - b. In B. adds in victims' rights at sentencing (which already exist in victims' rights statutes)
 - 2. Amends other statutes related to capital cases
 - 3. No movement



- i. SB1645 Sexual assault kit; victim access, Sen Burch/Alston (NO MOVEMENT)
 - 1. Adds 13-1426 (J) A public accredited crime laboratory shall provide a secure internet portal that allows a victim to anonymously access the following information relating to the victims sexual assault kit evidence: the current location of the sexual assault kit, the date of the testing, the results of the testing, whether a DNA profile was obtained from the sexual assault kit evidence.
